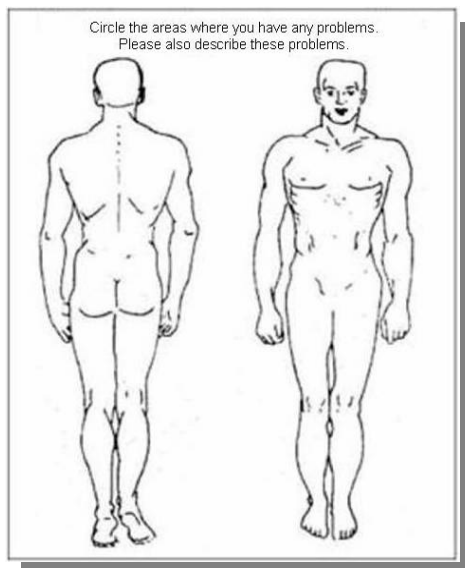

INFORMED CONSENT FOR CHIROPRACTIC CARE

Changes to the law now require all practitioners who manipulate the spine to warn patients of material risks. In extremely rare circumstances, some treatments of the neck may damage arteries in the neck and give rise to stroke or stroke-like symptoms. These are very rare events (approx 1: 100,000 to 1: 400,000) but if they occur have been known to cause stroke sometimes with serious injury such as quadriplegia or death. The risk of these most catastrophic events is extremely rare.

Other very slight risks include strain/injury to a ligament or disc in the neck (less than 1 in 139,000) or the low back (1 in 62,000). [Dvorak study in Principles and Practice of Chiropractic, Haldeman.]

Chiropractic adjustments (manipulations) of the spine are internationally recognised as being far safer in dealing with neck and low back pain than medication and many other alternatives. (A Risk Assessment of Cervical Manipulation, JMPT, 1995. Manga Report, Ontario Ministry of Health, 1993.)
